Mrs. Erin Baker will be with us as a counsellor every Tuesday and we are very lucky that Mrs. Toth will be sharing her Numeracy leadership with us one day each week as well. Our Parent Advisory Committee (PAC) will meet at the school at 7:00 pm, more details in next week's news letter.

There is nothing more important to us then keeping our McLeod family safe. For this reason, McLeod will be a NUT FREE school again this year. It is essential that we do our best to keep our students and staff with life-threatening allergies as safe as possible. No peanuts, brazil nuts or hazelnuts (ie – Nutella) will be permitted in our building. If a student brings any food to school containing these ingredients,

the item will be returned home to you. We are also working with Public Health to ensure our staff are trained in the necessary procedures in the event of an anaphylactic reaction. THANK YOU for your kindness and caring as we look after our kids and adults.

Each year we have a theme for the year. Last year we worked on, and sang about, WE'RE ALL IN THIS TOGETHER! This year our theme is WEB — Where Everybody Belongs.

This newsletter includes LOTS of information, and we hope you will take the time to check it all out. If you answered "YES" to one of the questions included under 'Key Symptoms of Illness' (excluding fever), your child should stay home for 24 hours from when the symptom started. If the symptom improves, your child may return to school when they feel well enough. If the symptom persists or worsens, seek a health assessment.

If you answered "YES" to two or more of the questions included under 'Symptoms of Illness' or your child has a fever, seek a health assessment. A health assessment includes calling 8-1-1, or a primary care provider like a physician or nurse practitioner. If a health assessment is required, your child should not return to school until COVID-19 has been excluded and symptoms have improved.

When a COVID-19 test is recommended by the health assessment:

☐ If the COVID-19 test is positive, your child should stay home unti	I you are told by public health to end self-
isolation. In most cases this is 10 days after the onset of symptoms	. Public health will contact everyone with a
positive test.	

☐ If the COVID-19 test is negative, your child can return to school once symptoms have improved and they feel well enough. Symptoms of common respiratory illnesses can persist for a week or more. Re-testing is not needed unless you develop a new illness.

☐ If a COVID-19 test is recommended but is not done because you choose not to have the test, or you do not seek a health assessment when recommended, and symptoms are not related to a previously diagnosed health condition, your child should stay home from school until 10 days after the onset of symptoms, and then they may return if they are feeling well enough.

If a COVID-19 test is not recommended by the health assessment, your child can return to school when symptoms improve, and they feel well enough. Testing may not be recommended if the assessment determines that the symptoms are due to another cause (i.e. not COVID-19).

If you answered "YES" to questions 2 or 3, use the COVID-19 Self-Assessment Tool to determine if you should seek testing for COVID19.

A health-care provider note (i.e. a doctor's note) is not required to confirm the health status of any individual.

#### Re: Student Accident Insurance

School District No. 91 (Nechako Lakes) does <u>not</u> provide accident insurance coverage for student injuries that occur on school premises or during school activities. Accidents can and do happen. Some injuries incur medical, dental or other expenses that are not covered by provincial health care or employer group plans. As a parent or guardian, you become responsible for these expenses.

The Board is empowered to make available the insuremykids® Protection Plan for students through Reliable Life Insurance Company. Participation in such a program is voluntary and the costs are to be paid by the parent or guardian.

This program offers a variety of plans and benefits at affordable rates. Benefits included are:

- dental expenses (resulting from an accident)
- total and permanent disability
- paralysis/loss of use
- special disability benefits
- death benefits

If your child participates in co-curricular activities or activities outside the school day, there is a plan tailored to your needs. All rates are one-time annual premiums. Family rates for 3 or more children are also offered.

#### **McLeod Elementary School Lunch Program**

September 2021

Welcome Back!

Summer has flown by and we are starting the school year with a BRAND NEW kitchen !! And our *Amazing Hot Lunch* program is all rearing to go!!

Our PAC will be overseeing our Meals Program using the Farm to School protocol. This is a wonderful program as we here at W. L. McLeod are very fortunate to have healthy meals prepared for us, using as much locally grown foods as possible. All meals will be pre-plated at this point. There will be a hand sanitizer station to be used by all students. It is VERY IMPORTANT that after sanitizing, students MUST NOT TOUCH their faces, hair or clothing, or other students.

Mrs. Heather Campbell-Stewart and Mrs. Alona Santos are our Farm-to-School champions and will be preparing the meals.

Mrs. Campbell-Stewart would love to get your menu ideas, but please keep in mind that the Guidelines for Foods Served in BC Schools must be followed.

The price for a student meal remains \$5.00, however, if you pre-pay & pre-order at least 10 meals in a month then each meal is discounted to \$4.50. A subsidy program is also available for families needing assistance. Please feel free to contact myself or your child's teacher if you would like further information about our meals subsidy program.

Students should hand in their orders before 9:00am. If a child comes to school without a lunch, we will try to contact the parents, to confirm that they should be supplied with a meal. They will be charged for the meal. If there is a field trip and you have pre-paid for a Hot Lunch, a bagged lunch will be sent with your child on the field trip. Please keep track of the dates you have pre-ordered Hot Lunch.

Please pay for meals in advance with either cash or cheque and if paying by cheque, please make **cheques** payable to SD 91. At this point, we do not accept E-transfers.

Be sure to send a morning snack for your child.

Forks, spoons, sauces/dressings, etc are not provided for students who bring their own lunch.

Students that are absent on a day that they have ordered a lunch will receive a credit on a future date of their choice, (please plan ahead). A credit slip will be issued for missed meals and MUST accompany the request as it is difficult to keep track of almost 300 students who have credits as they are often not used immediately.

If a student comes to school late and is buying a lunch that day, they will need to advise me at the office upon arrival. Also, our Backpack program is in need of 500mL food containers. Please send them to the office with your child if you have any you would like to rehome.

# Violence Threat/Risk Assessment: Fair Notice and Process

### What is a threat?

A threat is an expression of intent to do harm or act out violently against someone or something. Threats may be verbal, written, drawn, posted on the Internet or made by gesture. Threats will be taken seriously, responded to and investigated.

# When is a Violence Threat/Risk Assessment started?

A Violence Threat/Risk Assessment will be started by behaviours such as:

- Serious violence or violence with intent to harm or kill
- Verbal/written threats to harm or kill others or self
- Internet threats to harm or kill others or self
- Possession of weapons (including replicas)
- Bomb threats and fire setting.
- Or similar behaviours

# What happens in a Violence Threat/Risk Assessment?

When a threat making or high risk behaviour is reported to the principal, the principal will activate the protocol and a team appropriate to the situation will be set up. Once the team has been activated, interviews may be held with the student(s), the threat maker, parents and the staff, to determine the level of risk and to plan an appropriate response. The team may include people from the community such as RCMP or counsellors.

# What are the purposes of a Violence Threat/Risk Assessment?

The purposes of a Violence Threat/ Risk Assessment are:

- To ensure the safety of students, staff, parents and others
- To ensure a full understanding of the context of the threat
- To begin to understand the factors that contribute to the threat maker's behaviour
- To be proactive in developing an intervention plan to address the emotional and physical needs of the threat maker
- To promote the emotional and physical safety of all.



### **Duty to Report**

To keep school communities safe and caring, staff, parents, students and community members must report all threat related behaviours to the principal. The principal will then activate the initial response.

# Can I refuse to be part of the Student Threat Assessment

process?

In order to ensure a safe and caring environment a threat assessment needs to be completed. It is important for everyone involved to engage in the process. If there is a reluctance to participate, the process will still be completed.

# School District No. 91 Values

School District No. 91 (Nechako Lakes) is committed to creating and maintaining school environments in which students, staff, parents, and others feel safe. Schools cannot ignore any threat of violence.

### Where can I get further information?

Please discuss this information with your children so that they understand the intent. Should you require further clarification, please contact your school principal or Manu Madhok, Superintendent of Schools at 250-567-2284.

### Fair Notice: Violence Threat/Risk Assessment

It is important that all students and staff of School District No. 91 (Nechako Lakes) be allowed to work in an environment free from harm. Threat making behaviour will not be tolerated. All threats and all high risk behaviours will be investigated and acted on accordingly. This may involve other agencies and Ministries including the RCMP. If your child is involved in threat making behaviour you will be contacted. (Code of Conduct Policy 502.1)

### W. L. McLeod Technology Policy

Technology refers to cell phones, IPADs, IPODs, video games, cameras, etc.

Technology is part of our school in many ways but it must not interfere with our learning, kindness and caring. It is expected that students will follow the discretion of the teachers regarding technology use for learning. Technology that interferes with a student's kindness and caring will be subject to confiscation by an adult.

Students in grades K to 3 are not to bring technology to school.

Grade 4 to 6 students may bring technology to school but:

- 1. The school takes no responsibility for the technology.
- 2. The technology must be left in the student's locker during class time unless requested by the teacher for a learning activity.
- 3. Taking pictures, videotaping and recording is not allowed (including by cell phone).
- 4. Technology is not to be used during a lockdown.
- 5. Students must follow the W.L. McLeod Responsible Internet Use Policy.
- 6. Students must follow all COVID-19 Guidelines while using technology including minimizing physical contact and not touching things that belong to others.

If a student does not follow the above policy:

- 1. the technology will be confiscated and given to the principal,
- 2. the parent/guardian will be asked to come to the school to claim the technology, and
- 3. the student may not be permitted to bring any technology to school for the remainder of the school year.

#### RESPONSIBLE INTERNET & TECHNOLOGY USE

The computer system is owned by the school. This Responsible Internet & Technology Use statement helps protect students, staff and the school by clearly stating what use of the computer resources and technology is acceptable and what is not.

- I will ask permission before using the internet.
- I will only look at or delete my own files
- I will only use e-mail when my teacher has approved it. The messages I send will be polite and sensible.
- I will not use the internet or technology to inappropriately communicate with others (i.e. cyber-bullying, making threats, etc.)
- I understand that I must never give my home address or phone number, or arrange to meet someone.
- I will not use internet chat.
- If I see anything I am unhappy with or I receive messages I do no like, I will tell a teacher immediately.
- I understand that the school may check my computer files and the internet sites I visit.
- I understand that if I deliberately break these rules, I may not be allowed to use the internet or computers.

The school may exercise its right to monitor the use of the school's computer systems, including access to websites, the interception of e-mail and the deletion of inappropriate materials where it believes unauthorized use of the school's computer system is or may be taking place, or the system is or may be being used for criminal purposes or for storing unauthorized or unlawful text, imagery or sound.

#### **Summary of COVID-19 Protocols at September 2021**

All guidelines will follow the directions of the Ministry of Education and Provincial Health Office and are subject to change.

- Mask wearing for all staff, students in grades 4-12 and visitors, when indoors and on buses.
   Mask wearing for K 3 is encouraged when indoors and on buses but remains a family/caregiver choice.
   Encouraging eligible students and staff to get vaccinated.
  - Daily Health Check for students and staff.
  - Staying home when sick and going home as soon as possible if sick at school.
  - Students who are feeling sick will wait for caregivers in the designated health room or an alternate space with 2M distance from others.
  - Daily attendance record keeping for students, staff and visitors. All visitors will sign in at our office.
  - HVAC protocols to ensure maximizing outside air. Our ventilation systems have been inspected and meet provincial guidelines.
  - Regular hand hygiene (hand washing or applying hand sanitizer) will occur throughout the day:
    - when entering/leaving the classroom or other spaces in the school including our playground,
    - before and after eating,
    - before and after using shared equipment (ie computers, PE, etc.).
  - Encouraging sneezing etiquette.
  - Cleaning of surfaces used by someone who has become sick.
  - Store bought treats may be brought in by families. Individually portioned treats are best and need to be handed out by staff following regular food-safe practices (ie. clean hands before handing out food).
  - In our gym classes:
    - Masks will continue to be worn but may be removed during high-intensity physical activity.
    - Students will continue to perform hand hygiene before and after gym.

- Assemblies. When we gather, we will follow room capacities and we will encourage spreading out as much as possible in the space.

- Physical distancing of 2M.
- Daytime custodians
- Remote or hybrid learning options.
